

New Mexico Lottery Authority Second-Chance Drawing Rules

Show Me Second-Chance Promotion

THE NMLA AT ITS SOLE DISCRETION MAY END OR CANCEL THIS PROMOTION AT ANY TIME. PROMOTION AND RULES ARE SUBJECT TO CHANGE AT THE NMLA'S DISCRETION AT ANY TIME.

1. Promotion Description

- a. The New Mexico Lottery Authority (NMLA) will conduct the Show Me Second-Chance Promotion (Promotion) according to these rules, the New Mexico Lottery Promo Zone Program Rules, and the Second-Chance and Promotional Drawing Rules.
- b. Six (6) drawings will be conducted to award:
 - i. Five (5) Build-Your-Own Trip Packages (Trip Package)
 - ii. One (1) Prize of one hundred thousand dollars (\$100,000) (\$100,000 Cash Prize)
- c. Five (5) Bonus Cash Drawings will be conducted to award:
 - i. Five (5) prizes of five thousand dollars (\$5,000) (Bonus Cash Prizes)

2. Entry Periods, Deadlines, and Drawing Dates

- a. Entries must be received no later than 11:59:59 PM MT on the Entry Deadline Dates listed in the Entry and Draw Schedule below.
- b. An entry submitted between an Entry Start Date and an Entry Deadline Date is only eligible for the corresponding drawing and an entry does not carry forward as an entry in a subsequent drawing(s). Drawings will be held after 10:00 AM MT on the dates below, or as soon as practical.
- c. Entry eligibility will be determined by the time/date of successful submission into the entry website for the Promotion.

4. Eligibility Requirements:

- a. Players must certify that they are at least eighteen (18) years of age.
- b. Players must enter through the Promo Zone program at nmlottery.com.
- c. Players that are not members of the Promo Zone program may join at nmlottery.com.
- d. Players must manually enter any eligible non-winning Scratcher ticket from Game #469 Show Me \$30,000!, Game #467 Show Me \$50,000!, or Game #468 Show Me \$100,000!
 - i. The twelve (12) digit ticket number is located on the back of the ticket above the barcode and the ten (10) digit entry number is located on the front of the ticket, underneath the scratch-off coating.
- e. Non-winning tickets from Game #469 Show Me \$30,000! will receive 3 entries. Non-winning tickets from Game #467 Show Me \$50,000! will receive 5 entries. Non-winning tickets from Game #468 Show Me \$100,000! will receive 10 entries.
- f. Players may submit multiple tickets. However, each ticket may only be entered once.
- g. Players may enter up to fifty (50) tickets per day.
- h. Players may win only one (1) time in each drawing but can win in any of the eleven (11) drawings.
- i. All entries received during the entry dates for a Trip Package drawing per the Entry and Draw Schedule are eligible for the Bonus Cash Drawing with the corresponding entry dates on the Bonus Cash Drawings Entry and Draw Schedule.
- j. Entries mailed or hand-delivered to the NMLA will be disqualified and will not be returned.

5. Prize Details

- a. Five (5) entries will be selected throughout the Promotion to win a Trip Package. The Trip Package is valued at approximately five thousand dollars (\$5,000).
- b. The Trip Package winner gets to build their own custom Trip Package, subject to availability and terms.
- c. One (1) entry will be selected to win the \$100,000 Cash Prize of one hundred thousand dollars (\$100,000).
- d. One (1) entry will be selected in each of the five (5) Bonus Cash Drawings to win five thousand dollars (\$5,000).

6. Drawing Procedures

- a. An NMLA Security representative will conduct the eleven (11) drawings, as indicated on the Entry and Draw Schedule and the Bonus Cash Drawings Entry and Draw Schedule, using a random number generator.
- b. One (1) entry will be selected in each of the eleven (11) drawings.
- c. Twenty (20) alternates will be selected for each drawing.

7. Selected Entry Notification

- a. The Procedures for Notification of Selected Entries of Second-Chance or Promotional Drawings will be followed.
- b. A selected entrant will be notified using the email address on file in the Promo Zone. In addition to the email, the NMLA may attempt to notify a selected entrant by phone.
- c. The selected entrant must acknowledge receipt of the email or phone call and/or submit the completed NMLA Claim Form within the timeframe specified by the NMLA. Failure to submit the completed NMLA Claim Form in the above designated timeframe may result in disqualification, in which case the first alternate will be contacted, and the same process will be followed.

8. Miscellaneous

- a. Exceptions or modifications to these rules must be approved in writing by the NMLA CEO and the NMLA EVP for Security.
- b. The selected entrant is responsible for all federal and state taxes associated with the Trip Package, \$100,000 Cash Prize, or Bonus Cash Prize upon submitting the NMLA Claim Form.
- c. There is no cash value option or substitutions for the Trip Package, except that the NMLA may substitute a prize of equal or greater value at its sole discretion.
- d. The selected entrant must determine the dates and destination of travel when completing the KRQE Trip Package paperwork.
- e. The Trip Package is non-transferable.
- f. If the Trip Package winner elects not to take the trip, a proxy may be appointed prior to KRQE booking the reservations. Once travel arrangements are booked by KRQE, the Trip Package cannot be changed.
- g. KRQE will provide the appropriate federal and state IRS Tax Forms to the Trip Package winner.
- h. The Trip Package reservations must be finalized with KRQE a minimum of sixty (60) days prior to the dates of travel. The person taking the trip is responsible for any additional expenses if changes are made to reservations after booking.

- i. It is the responsibility of the selected entrant to contact KRQE/Ronn Weese at 505.764.5262 or by email at ronn.weese@krqe.com with the names and birth dates of both persons traveling, if applicable. The TSA requires the same names that are on the driver's licenses or picture IDs be on the airfare tickets.
- j. The Trip Package does not include any additional ground transportation, gratuity, meals, or other amenities.
- k. The person taking the Trip Package must present a credit card at check in at the hotel to cover any incidental expenses, if applicable.
- l. The \$100,000 Cash Prize winner will receive an IRS Form W-2G.
- m. Failure to provide accurate information could cause a player selected as a drawing winner to be disqualified.
- n. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- o. Use or distribution of "auto" software programs or other similar software programs or applications to enter tickets or ticket codes into any drawing is prohibited. If discovered to be using such a program or application, a player's entries may be disqualified.
- p. Void where prohibited by law.
