

# New Mexico Lottery Authority Second-Chance Drawing Rules

## JURASSIC PARK Second-Chance Promotion

**THE NMLA AT ITS SOLE DISCRETION MAY END OR CANCEL THIS PROMOTION AT ANY TIME.**  
**PROMOTION AND RULES ARE SUBJECT TO CHANGE AT THE NMLA'S DISCRETION AT ANY TIME.**

### 1. Promotion Description

- a. The New Mexico Lottery Authority (NMLA) will conduct the JURASSIC PARK Second-Chance Promotion (Promotion) according to these rules, the New Mexico Lottery Promo Zone Program Rules, and the Second-Chance and Promotional Drawing Rules.
- b. Three (3) drawings will be conducted:
  - i. Two (2) Pinball Machine Drawings will be conducted to award two (2) JURASSIC PARK Pinball Machines (Pinball Machine).
  - ii. One (1) Grand Prize Drawing will be conducted to award one (1) trip to Hawaii (Trip Prize) to participate in the \$1,000,000 JACKPOT CHALLENGE (Event).

### 2. Entry Period, Deadline, and Drawing Date

- a. Entries must be received no later than 11:59:59 PM MT on the Entry Deadline Dates listed in the Entry and Draw Schedule below.
- b. An entry submitted between an Entry Start Date and an Entry Deadline Date is only eligible for the corresponding drawing and an entry does not carry forward as an entry in a subsequent drawing(s), except that all entries submitted during the Promotion are eligible for the Grand Prize Drawing (Draw 3). Drawings will be held after 10:00 AM MT on the dates below, or as soon as practicable.
- c. The Entry Deadline and Drawing Date for the Grand Prize Drawing will be posted on the NMLA website once determined. The drawing will be held on the date posted, or as soon as practical.
- d. Entry eligibility will be determined by the time/date of successful submission into the entry website for the Promotion.

#### **4. Eligibility Requirements**

- a. Players must certify that they are at least eighteen (18) years of age.
- b. Players must enter through the Promo Zone program at [nmlottery.com](http://nmlottery.com).
- c. Players that are not members of the Promo Zone program may join at [nmlottery.com](http://nmlottery.com).
- d. Players must manually enter an eligible non-winning ticket from Game #632 JURASSIC PARK.
  - i. The twelve (12) digit ticket number is located on the back of the ticket above the barcode and the ten (10) digit entry number is located on the front of the ticket, underneath the scratch-off coating.
- e. Players may submit multiple entries. However, each ticket may only be entered once.
- f. Players may win only one (1) time in each drawing but can win in any of the three (3) drawings.
- g. Players may enter up to fifty (50) tickets per day.
- h. Entries mailed or hand delivered to the NMLA will be disqualified and will not be returned.

#### **5. Prize Details**

- a. One (1) entry will be selected in each of the Pinball Machine Drawings to win one (1) Pinball Machine valued at approximately five thousand dollars (\$5,000).
  - i. The Pinball Machine is not assembled and will be curbside delivered to a physical address in New Mexico.
  - ii. The NMLA is not responsible for any Pinball Machine defects.
- b. One (1) entry will be selected in the Grand Prize Drawing (Trip Prize Winner) to win the Trip Prize, valued at approximately fourteen thousand eight hundred ninety-five dollars and eighty-three cents (\$14,895.83) including federal and state tax withholdings.
- c. The Trip Prize includes:
  - i. Six (6) day, five (5) night trip for two (2) people to Honolulu, Hawaii, in or around November 2026;
  - ii. Roundtrip coach airfare for up to two (2) people (two (2) seats) from any airport within the United States to Daniel K. Inouye International Airport in Honolulu, Hawaii;
  - iii. Ground transfers between Daniel K. Inouye International Airport and the destination hotel and between hosted events, if such transportation is reasonably required;
  - iv. Five (5) nights' hotel accommodations in Oahu, Hawaii (one (1) double occupancy hotel room and tax only);
  - v. One thousand dollars (\$1,000) spending money;
  - vi. Admission to the Event venue for the Trip Prize Winner and guest; and
  - vii. The Trip Prize Winner (or assigned proxy) shall have one (1) chance to participate in the Event with participants from other lottery jurisdictions for a chance to win up to one million dollars (\$1,000,000) as described in the \$1,000,000 JACKPOT CHALLENGE OFFICIAL DETAILS (Official Event Details). The Trip Prize Winner will be provided a copy of the Official Event Details, including how the Event will be conducted, prior to the trip departure. The Trip Prize Winner's guest may sit with the Trip Prize Winner but will not be eligible to be a participant in the Event, unless they have been designated as the Trip Prize Winner's proxy.
- d. Any questions regarding the Event, including questions regarding assignment of proxies, prize payments, tax liability, or withholding for prizes should be directed to Scientific Games, LLC (SG), the NMLA's vendor responsible for Trip Prize fulfillment, at 1-800-201-0108.
- e. Participation in the Event may be subject to other local, state, and federal laws.

## **6. Drawing Procedures**

- a. An NMLA Security representative will conduct the three (3) drawings, as indicated on the Entry and Draw Schedule, using a random number generator.
- b. One (1) entry will be selected in each of the two (2) Pinball Machine Drawings.
- c. One (1) entry will be selected in the Grand Prize Drawing.
- d. Three (3) alternates will be selected for each of the three (3) drawings.
- e. The odds of being selected in a drawing depend on the number of entries received.

## **7. Selected Entry Notification**

- a. The Procedures for Notification of Selected Entries of Second Chance or Promotional Drawings will be followed.
- b. A selected entrant will be notified using the email address on file in the Promo Zone. In addition to the email, the NMLA may attempt to notify a selected entrant by phone.
- c. The selected entrant must acknowledge receipt of the email or phone call and/or submit the completed NMLA Claim Form within the timeframe specified by the NMLA. Failure to submit the completed NMLA Claim Form in the designated timeframe may result in disqualification, in which case the first alternate will be contacted, and the same process will be followed.

## **8. Miscellaneous**

- a. Exceptions or modifications to these rules must be approved in writing by the NMLA CEO and the NMLA EVP for Security.
- b. The selected entrants in the Pinball Machine Drawings are responsible for all federal and state taxes associated with the pinball machine prize upon submitting the NMLA Claim Form.
- c. The selected entrant in the Grand Prize Drawing is responsible for all federal and state taxes associated with the Trip Prize and the Event upon submitting the NMLA Claim Form.
- d. The winners in the Pinball Machine Drawings will receive an IRS Form W-2G from the NMLA.
- e. SG shall withhold and deposit the minimum required federal tax withholdings and any applicable state tax withholdings on behalf of the Trip Prize Winner. SG shall provide an IRS Form W-2G to the Trip Prize Winner.
- f. There is no cash value option or substitutions for a prize, except that the NMLA may substitute a prize of equal or great value at its sole discretion.
- g. No compensation will be paid in lieu of any cancelled event or any other element of the Trip Prize.
- h. Upon NMLA Claim Form verification, the Trip Prize Winner's name and information will be given to SG for Trip Prize fulfillment.
- i. The Trip Prize Winner (or proxy assigned by the Trip Prize Winner) must be at least eighteen (18) years of age to be eligible to participate in the Event.
- j. The Trip Prize Winner may pre-designate a proxy to participate in the Event on the Trip Prize Winner's behalf. A proxy must be at least eighteen (18) years of age. The Trip Prize Winner shall receive any cash prizes won by the proxy during the Event.
- k. The Trip Prize Winner or guest must present a valid credit card or shall be required to post a cash deposit for incidentals to check into the hotel.
- l. It is the responsibility of the Trip Prize Winner and guest to comply with the REAL ID Act to the extent such Act is applicable to the Trip Prize Winner's and guest's air travel.
- m. The Trip Prize Winner and guest are subject to a background investigation prior to the Trip Prize.
- n. At the discretion of the NMLA or SG, a proxy may be appointed to represent the Trip Prize Winner.

- o. Only the Trip Prize Winner is eligible to win an Event prize. The Trip Prize Winner's guest or proxy is not eligible to win an Event prize.
- p. The Trip Prize Winner is solely responsible for the actions of the Trip Prize Winner's guest. If the guest is a minor, the Trip Prize Winner must either be the parent or legal guardian of such guest or must present a notarized, written consent from the minor's parent or legal guardian for the minor guest to accompany the Trip Prize Winner on the Trip Prize trip.
- q. If the Winner elects not to take the trip, elects to not take a guest, or whose guest, for any reason, does not actually take the trip, then the Winner is still subject to the full amount of any taxes due on the total value of the Trip Prize.
- r. The Trip Prize does not include mileage, insurance, gratuities, meals, parking fees, baggage fees, alcoholic beverages, personal expenses such as telephone calls, valet service, laundry, incidentals and the like, revision or cancelation fees which may be charged by the hotel or other suppliers, or any other items not expressly specified.
- s. No prize element substitution, cash substitution, assignment, or transfer of the Trip Prize or any elements thereof is permitted. Any unused elements of the Trip Prize will be forfeited, will not be redeemable for cash, and will not reduce the prize value awarded for tax purposes.
- t. The Trip Prize Winner is subject to travel requirements provided by SG. The Trip Prize Winner may forfeit any or all of the travel portion of the Trip Prize if the Trip Prize Winner misses the flight, fails to check in to the participating hotel, or otherwise fails to arrive at a scheduled participation time, including the Event. In such case, the NMLA or SG shall appoint a proxy to play the Event for the Trip Prize Winner, and the Trip Prize Winner shall receive any prize won by the proxy.
- u. Failure to provide accurate information could cause a player selected as a drawing winner to be disqualified.
- v. The NMLA reserves the right to assign a designee(s) to perform the responsibilities of parties specifically assigned duties within these rules.
- w. Upon submitting an entry, the player(s) agree that the NMLA may use their name, voice, photograph, video, any social media postings, and/or likeness in any form for the purpose of advertising and/or publicizing the NMLA.
- x. Use or distribution of "auto" software programs, or other similar software programs or applications to enter ticket or ticket codes into any drawing is prohibited. If discovered to be using such a program or application, a player's entries may be disqualified.
- y. Universal Studios Licensing LLC ("Universal") and Amblin Entertainment, Inc. ("Amblin"), each of their parents and/or any of their subsidiaries, affiliates, or licensors (Universal, Amblin, and each of their parents, subsidiaries, affiliates, and licensors are collectively referred to hereinafter as the "Universal Entities") are not sponsors or administrators of the Event. The Trip Prize Winner is providing information to SG and not to the Universal Entities.
- z. The NMLA, SG, or other companies including, but not limited to, the Universal Entities or its affiliates directly associated with the Promotion will not be responsible to players or to any other person for data entry errors resulting from or caused by the entering, keying, or mis-keying of the required ticket information by players.
- aa. Void where prohibited by law.
